2024 MOTORCYCLE STICKER

PROCEDURE:

1. RESIDENT

- a. For Resident whose OR/CR is Registered/transferred to their name. they must apply thru our Online Website at bffhai.znergee.com, attach photocopy of current LTO Official Receipt (OR) and Certificate of Registration (CR) but for renewal follow the Video shown in our website. Present original OR and CR when required for further verification.
- b. If the O.R. / C.R. is not in the name of the applicant, download a form thru our website and attach NOTARIZED deed of sale with 2 Valid ID's of seller and buyer indicating your address in BF homes Subdivision. If the address is not in bf homes, Submit proof of residency such as Primary Government ID, Utility bills, among others. Bring the documents at BFFHAI (for approval of the assigned Officer of the day). Deed of sale will be considered valid for only one year from the time of execution or notary after which, the applicant will be considered as non-resident.
- c. Any two (2) government issued Id's

2. NON-RESIDENT

- A. Applicant must be endorsed by a bonafide resident of BF Homes and must also signed & stamped by the authorized signatory of the local association of the resident-sponsor.
- B. Any two (2) government issued Id's and VALID NBI OR POLICE CLEARANCE shall be required for motorcycles.

3. Application for motorcycles must be stamped by BFFHAI Security Office (LOUD MUFFLERS WILL NOT BE ENDORSED unless it passes the standard set by BFFHAI).

4. Elizalde gate is for the exclusive use of homeowners with VALID BFFHAI resident stickers.

5. Use only appropriate lanes at the entrance and exit gates.

6. You are in a residential zone. OBSERVE MAX. SPEED OF 40 KPH, traffic signs and refrain from blowing your vehicle horn unnecessarily.

7. BFFHAI reserves the right to REMOVE / CONFISCATE the sticker and/or DENY ENTRY in case of violation of BFFHAI's Traffic Rules and Regulations.

8. The issuance of this sticker does not carry any acceptance of liability on the part of BFFHAI.

9. Lost / stolen or damaged stickers shall be replaced after paying a replacement fee of P150.00 and a DULY NOTARIZED Affidavit of Loss.

E. APPLICANT'S UNDERTAKING

I HEREBY BIND MYSELF TO FOLLOW ALL RULES AND REGULATION AS STATED ABOVE HEREOF AND THAT UPON SALE OR DISPOSAL OF MY MOTORCYCLE I COMMIT TO REMOVE THE VEHICLES STICKER AND RETURN THE SAME TO THE BFFHAI OFFICE.
I HEREBY FURTHER BIND MYSELF TO THE FOLLOWING.

1. THAT THE STICKER IS NON-TRANSFERRABLE AND WILL BE PENALIZED WHEN TRANSFERRED.
2. THAT THE BFFHAI RESERVES THE RIGHT TO CONFISCATE THE STICKER FOR ANY VIOLATION OF THE RULES AND REGULATIONS OF BFFHAI, FOR ANY MISDECLARATION / MISREPRESENTATION IN THE APPLICATION FORM AND FOR THE MISUSE OF THE STICKER.
3. THAT A COPY OF THE BFFHAI OFFICIAL RECEIPT SHALL KEPT IN THE VEHICLE AT ALL TIMES.
4. THAT I UNDERSTAND AND AGREE THAT MY MOTOR VEHICLE MAY NOT BE ALLOWED ENTRY AT ANY OF THE GATES FROM 12 MIDNIGHT TO 5 AM DAILY. (for non-resident motorcycle only)
5. I AM FULLY AWARE THAT BFFHAI RETAINS PERMANENT OWNERSHIP OF THE STICKER AND ISSUED TO APPLICANTS ONLY AS A PRIVILEGE OF PASSAGE; HENCE, BFFHAI HAS THE LEGAL RIGHT TO INITIATE AND FILE ANY, AND ALL CASES RELATIVE TO THE STICKER.
6. THIS PRIVATE SUBDIVISION STICKER IS ISSUED ONLY AS A PRIVILEGE AND NOT A RIGHT.
